In terms of the J&K Compassionate Appointment Rules notified vide SRO-43, dated-22-02-1994, as amended from time to time, sanction is hereby accorded to the temporary appointment of Mr. Prayan, S/o: Lt. Sh. Raju Singh, Ex-Chowkidar of Directorate of YSS as Multitasking Staff/Class IV (Chowkidar) against vacant post in Directorate of Youth Services & Sports J&K in the pay Level SL-1(14800-47100) in the Youth Services & Sports Department under SRO-43 of 1994.

The appointee shall report in the Directorate of Youth Services & Sports J&K Jammu within a period of 21 days from the date of issuance of this order and shall be allowed to join only after the production of the following documents/certificates (in original) to be verified subsequently:

1. Academic Qualification Certificate.
2. Date of Birth Certificate.
3. Domicile Certificate.
4. Current Marital Status.
5. Health Certificate from the concerned Chief Medical Officer of the District.
6. Dependent Certificate issued by the concerned Assistant Commissioner Revenue.
7. No Loan Certificate under Self Employment Scheme from DIC concerned and Employment Department.
8. All other relevant documents as are required under SRO-43/1994, amended from time to time.

The appointment of the appointee, shall further be subject to the following conditions:

- a. That he shall give an undertaking in the shape of an affidavit to the effect that if, on verification, genuineness of the qualification certificates from the concerned issuing authority is found fake/forged, the claim of the appointee for appointment as Multitasking Staff/Class IV (Chowkidar) shall deemed to have been cancelled ab-initio and the legal action as warranted under rules shall be initiated against him.
- b. The salary of the appointee shall not be drawn and disbursed to him unless satisfactory report in respect of (a) above is received in his favour.

- c. The appointment of the candidate shall be governed by the "New Pension Scheme "as per SRO-400 of 2009, dated-24-12-2009.
- d. The appointment of the candidate shall be governed in terms of Jammu and Kashmir (condition of service, pay and allowance) and fixation of tenure, 2020 notified vide S.O. 192 of 2020, dated-17-06-2020.
- e. If the appointee fails to report within a period of 21 (twenty-one) days from the date of issuance of this order, he shall forego his right to appointment which shall be deemed to have been cancelled ab-initio without any further notice.
- f. The Drawing and Disbursing Officer shall ensure that no other dependent member of the deceased has availed the benefits of SRO-43 and the appointee whose case for compassionate appointment is considered is the same person whose dependency has been authenticated by ACR/ADC.

This order is however, subject to outcome of writ petition(s) if any, pending in any competent Court of Law.
