Whereas, the Directorate of Youth Services & Sports, J&K vide order no. DG-YSS/Estt/455-79 Dated:- 09-04-2025, constituted District Level Committees headed by the concerned District Youth Services & Sports Officers and accordingly authorized these committees to prepare the District wise seniority of Physical Education Teachers as per rules in vogue and it was further ordered that the concerned Joint Directors Youth Services & Sports will examine the draft seniority lists and ensure that all the rules & regulations governing the formulation of seniority list are strictly adhered to. The final seniority lists shall be issued only after being vetted by the concerned Joint Directors YSS Jammu/Kashmir; and


Whereas, the updated seniority list is also vetted by the Joint Director Youth Services & Sports concerned in terms of rules in vogue.
