
SO:____ In exercise of the powers conferred by the provision to section 309 of the constitution of India, the Lt. Governor hereby makes the following rules namely:

1. Short Title & Commencement:

- (1) These rules may be called the Jammu & Kashmir-Youth Services and Sports (Gazetted) Service Recruitment Rules 2022.
- (2) They shall come into force from the date of their publication in the Government Gazette.
- 2. **Definitions:** In these rules, unless the context otherwise requires:
 - a) "Union Territory" means the Jammu and Kashmir UT;
 - b) "Government" means the Government of Jammu and Kashmir;
 - c) "Rules" means the Jammu & Kashmir Youth Services and Sports (Gazetted) Service Recruitment Rules, 2021.
 - d) "Administrative Department" means the Department of the Government in the Civil Secretariat holding the Administrative charge of the service;
 - e) "Cadre" means the cadre of the service;
 - f) "Commission" means the Jammu & Kashmir Public Service Commission;
 - g) "Member of the Service" means a person appointed to a post in the (Gazetted) Service under the provisions of these rules;
 - h) "Service" means the Jammu and Kashmir Youth Services & Sports (Gazetted) Service Recruitment Rules;
 - i) "Schedule" means the schedule(s) annexed to these rules;
 - j) Words and expressions used in the these rules but not defined, shall have the same meaning as are assigned to them in the Jammu and Kashmir Civil Services (Classification, Control and Appeal) Rules 1956/Jammu and Kashmir Civil Services Regulations.

3. Constitution of Service:

(1) From the date of commencement of these rules there shall be constituted the "J&K Youth Services and Sports (Gazetted) Service Recruitment Rules".



- (2) The Government may, at the commencement of these rules, appoint to the service any person who at the commencement of these rules is holding in a substantive capacity any post included in the cadre of the services.
- (3) Provided that for the purposes of initial constitutions of the service, the person holding any post in a substantive capacity to which he was appointed by the competent authority under rules included in the cadre of the service in its sanctioned scale of pay shall be deemed to have been appointed to the service under these rules if he/she is fully qualified to hold the post under these rules unless he/she opts otherwise within 15 days from the commencement of these rules.

Explanation:

The word "holding" means a person holding a post included in the cadre of the Jammu and Kashmir, Youth Services and Sports (Gazetted) Services in its sanctioned scale of pay on regular basis under orders of the competent authority and will not cover the persons holding a post on ex-cadre/deputation basis or on adhoc basis or in a stop gap arrangement.

04. Strength and Composition of the Service:

(1) The authorized permanent and temporary strength of the cadre and the nature of the posts included therein shall be determined by the Government, from time to time and shall at the initial constitution of the service under these rules, be such as specified in the Schedule-I annexed to these rules:

Provided that the Government may create temporary posts in the cadre or the service for specified period or purpose as may be considered necessary from time to time.

(2) The Government shall, at the interval of every five years or at such other intervals as may be necessary, re-examine the strength and composition of the cadre of the service and make such alternations therein as it deems fit.

05. Qualification & Method of Recruitment:

- (1) No person shall be eligible for appointment or promotion to any post in any class, category or grade in the service unless he/she possesses the qualifications as laid down in the schedule-II-A and II-B and fulfills other requirements of recruitment as provided in the rules and orders for the time being in force.
- (2) Appointments to a service or class shall be made:
 - a) by promotion or by transfer from another service of class; or
 - b) by direct recruitment; or
- c) Partly by (a) and partly (b) in the ratio and in manner mentioned against each post in Schedule-II appended to these rules and under Career Advance Scheme.



- (i) Provided that all the posts under direct recruitment shall be filled through J&K Public Services Commission as per the rules/order of the Government issued for the purpose.
- (ii) Provided further all posts to be filled by promotion shall be filled through Departmental Promotion Committee/J&K Public Service Commission, unless any post/category of posts is exempted from the purview of the Public Service Commission in terms of J&K Public Service Commission (Limitation Functions) Regulations, 1957 by the Government by specific order.
- (iii) The departments shall refer vacancies in the direct/promotion quota to Public Service Commission and Departmental Promotion Committees, as per SRO-166 dated: 14-06-2005.

06. Career Advancement Scheme:

Assistant Professors and Associate Professors

- Persons entering the teaching profession in Colleges shall be designated as Assistant Professors and placed in the pay band of 15600-39100 with AGP of Rs. 6000/-. Lecturers already in services in the pre-revised scale of Rs. 8000-13500, shall be re-designated as Assistant Professors with the said AGP of Rs. 6000/-
- An Assistant Professor in Physical Education with completed service of 4 years, possessing Ph.D Degree in the relevant discipline shall be eligible, for moving up to AGP of Rs. 7000.
- iii. Assistant Professors in Physical Education possessing M.Phil degree or post graduate degree in professional courses shall be eligible for the AGP of Rs. 7000 after completion of 5 years service as Assistant Professors in Physical Education.
- iv. Assistant Professors in Physical Education who do not have Ph.D or M.Phil course shall be eligible for the AGP of Rs. 7000 only after completion of 6 years service as Assistant Professors in Physical Education.
- v. The upward movement from AGP of Rs. 6000 to AGP of Rs. 7000 for all Assistant Professors in Physical Education shall be subject to their satisfying other conditions as laid down by the AICTE (Schedule-II).
- vi. Assistant Professors in Physical Education with completed service of 5 years at the AGP of Rs. 7000 shall be eligible subject to other requirements laid down by the AICTE (Schedule-II), to move up to the AGP of Rs. 8000.
- vii. Assistant Professors completing 3 years of teaching in the AGP of Rs. 8000 shall be eligible, subject to other conditions that may be prescribed by the UGC and the University, to move to the Pay Band of Rs 37400-67000 with AGP of Rs 9000 and to be designated as Associate Professor.

07 Promotion to the post of Principal:-

The post of Principal of Government College of Physical Education Ganderbal shall be filled in the Pay Band of Rs. 37400-67000 with AGP Rs. 10000/- (prerevised) under rule as prescribed in Schedule – II of these rules.



08 Probation:

- (1) Persons appointed to the service either by direct recruitment or by promotion shall be "on probation for two years" and their confirmation for class or category shall be made under the provisions of Jammu and Kashmir Civil Services (Classification, Control and Appeal) Rules, 1956.
- (2) The pay of a person appointed to the service under these rules shall be regularized as per the provisions of Jammu and Kashmir Civil Services Regulations or General Rules as issued from time to time.

09. Reservation in appointments:

While making appointments either by promotion or by direct recruitment, reservation shall be made in accordance with the rules and orders issued from time to time for members of Scheduled Caste/Scheduled Tribes/Backward Classes or any other category or class of permanent residents of UT under the provisions of Jammu and Kashmir Reservation Act, 2004 & the Reservation Rules in force.

1. Training and Departmental Examinations:

Persons appointed to the service by competitive examination shall be required to undergo such training from time to time during the course of probation and to pass during the period of probation or trial such departmental examination as the Government may prescribe:

Provided that the Government may exempt persons from such training or departmental examination, either wholly or partly, from such training or persons who have passed a departmental examination or undergone training declared by Government to be equivalent to a departmental examination or training prescribed under these rules.

2. Eligibility of Government Servants for Direct Recruitment:

A person already in the Government service may apply through proper channel for direct recruitment to a vacant post in any particular class or category in the service if he/she possess the educational and other qualifications prescribed for recruitment to such class or category of post. The upper age limit of such Government servants shall be as provided in the general rules.

Provided that in the case of a post which required a higher degree or specialization and or experience, the Government may prescribe higher age limit.

3. Maintenance of Seniority Lists:

Seniority of the members of the service shall be regulated under the Jammu and Kashmir Civil Services (Classification, Control and Appeal) Rules, 1956. The Administrative Department shall maintain an up to date and final seniority list of members of the service.



4. Residuary Matters:

In regard to matters not specifically covered by these rules, the members of the service shall be governed by the rules/regulations and orders applicable to the State Civil Service in general.

5. Interpretation:

If any question, arises relating to the interpretation of these rules, the matter shall be referred to the Administrative Department whose decisions thereon shall be final and binding.

15. Repeal and Savings:

- (1) The Jammu and Kashmir Youth Services and Sports (Gazetted) Recruitment Rules, 2013 are hereby repealed.
- (2) Notwithstanding such repeal, any appointment order made or action taken under the provisions of the rules so repealed shall be deemed to have been made or taken under the corresponding provisions of these rules.
