Whereas, this office has received 02 objections from the stakeholders within 21 days from the Date of Publication of the Notice in the newspaper through Department of Information and Public Relations, J&K

Whereas, the updated seniority list is also vetted by the Joint Director Youth Services & Sports concerned in terms of rules in vogue.

Whereas, the District Level Committee headed by the undersigned had convened the meeting on 24 -12-2025 and the objections received by this office have been examined/scrutinized thoroughly by the committee and necessary corrections/additions/deletions have been made in the seniority list as indicated below;


