The candidate who fulfill the following qualification/condition as prescribed in Government order No: 808-GAD of 2008 dated: 17-06-2008, 946-GAD of 2008 dated: 15-07-2008, 1090-GAD of 2008 dated: 14-08-2008 & 733-GAD of 2010 dt: 24-06.2010 should only apply:-

i) A person who has represented India at the Olympic Games, Asian Games, SAARC Games, Common Wealth Games or other officially recognized Test Matches/World Cup Competitions in any of the Games/Sports mentioned below.

Or

ii) A person who has participated & secured one of the first three positions in the individual events or was a member of the team which obtained first, second or 3<sup>rd</sup> position or has participated twice or more in the same discipline in the National Championship in any of the Sports or Games as mentioned below.

The disciplines (Sports/Games) covered under the above rules are Athletics, Badminton, Basketball, Cricket, Football, Hockey, Swimming, Table Tennis, Volleyball, Tennis, Weight lifting, Wrestling (International Style), Boxing, Cycling, Gymnastics, Judo, Shooting, Archery, Equestrian, Handball, Rowing, Roller/Ice Skating, Skiing, Squash, Billiards & Snooker, Chess, Golf, Kabaddi, Karate, Kayaking & Canoeing, Polo, Power lifting, Taekwondo, Yachting, Kho-Kho, Body Building, Ball Badminton, Bridge, Tenni-Koit, Carrom, Softball, Wushu, Sport Climbing, Thang-Ta, Base-Ball, and all other games falling within the purview of Indian Olympic Association and/or recognized by the Government of India.

The other terms & conditions as enclosed with the Application Form will also be applicable for determining the eligibility of the candidates for grant of sports category weightage. 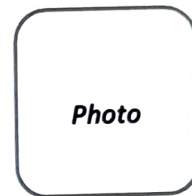

**Sub:- Other terms & conditions/guidelines for grant of Sports Category Weightage.**

The candidate should also follow following terms & conditions/guidelines in addition to qualifying criteria while filling up the application form for grant of sports category weightage.

1. Provided that for purpose of determination of the merit under sports category for selection to Professional Courses at Post Graduate/Graduate/Diploma level etc. 60% weightage shall be given to the merit obtained by the candidate in the Entrance test conducted by the Selection agency & 40% weightage shall be given to the level of sports participation. The 40% merit shall be distributed as per the following criteria:-

2. The candidates who fulfill the above qualification in addition to minimum required Academic qualification should be of the age as may be prescribed by the Board of Professional Entrance Examinations, J&K. The applications duly completed enclosing their with the following certificates in original as well as a set of Photostat copies duly attested by the competent authority should deposited with respective Sports Officers of the Sports Council within the stipulated date:-

- i) Date of birth certificate.
- ii) State subject certificate.
- iii) Sports achievement certificates duly affixed with a photograph and verified by the respective Sports Associations/Directorate of Youth Services & Sports/other competent bodies.
- iv) Certificate of qualifying examination.
- v) An affidavit affirming the authenticity of the claim(s) duly attested by the Magistrate (1<sup>st</sup> Class) on non-judicial stamp paper on prescribed format available in the office of Sports Officers, Sports Council Srinagar/Jammu with the application format.

3. The applications should be deposited with the following officers of the Sports Council within the prescribed period as per the Council advertisements. The applications received before or after the prescribed dates or through other agencies shall not be entertained:-
  - a) Divisional Sports Officer, J&K Sports Council, Administrative Block Bakshi Stadium, Srinagar.
  - b) Divisional Sports Officer J&K Sports Council, New Indoor Sports Complex, M.A. Stadium Jammu.
4. Incomplete application form will not be considered.
5. The certificate of participation in International events will be considered and recognized by the Sports Council if these are issued by following and genuinely signed by its office bearers including the Organising Secretary or/and Secretary General:-
  - a) Respective Host Country, or.
  - b) Respective International Federation, or.
  - c) Respective recognized National Federation.
6. The certificates issued by the recognized National Federation will only be accepted.
7. The certificate of participation National level competitions will be considered or recognized by the Council only if these issued by the respective National Federation or its affiliated State Units authorized to conduct the particular event. The certificate should be genuinely signed by the competent office bearers of the respective National Federation including the Secretary General or/and Organising Secretary of the event. In case of Cricket or some other discipline, the certificates issued by the recognized State Sports Association will be considered against an affidavit to the effect that the Organisers or Board of Control for Cricket in India/some other National Federation have not issued the participation certificates.
8. After the applications are scrutinized by the Committee, the Sports Council will notify the list of eligible and ineligible candidates and will call objections/grievances from the candidates with regard to any applicant, whose name is notified, regarding his/her claim under Sports Category. The Committee will consider the objections/grievances of any applicant. The decision of the Committee shall be final in such matters.
9. The candidate should deposit the sports certificates in original alongwith the applications which shall be retained by the Council for 15 days from the date of declaration of results by the Board of Professional Entrance Examinations. A set of photo copies duly attested/verified should be submitted by the candidate. The candidate should also give complete address and telephone number, if any for correspondence/contact.
10. The sports achievement certificates produced by the candidates will be subject to cross checking whenever found necessary.
11. Candidates found guilty of impersonation or submitting fabricated/tampered documents or making statements which are incorrect/false or suppressing material information may, in addition tendering him/her liable for criminal prosecution, be debarred, or for a specific period, from being considered for any or all admission made under these rules.

12. The applications shall be considered on the basis of records/documents produced by the candidates and verified by the respective State sports Associations/other competent bodies.
13. As per the decisions taken in the 53<sup>rd</sup> meeting of the Sports Council held on 19-02-2013 under the chairmanship of Hon'ble Chief Minister (President, Sports Council), the sports certificates of the applicants earned from April, 2013 onwards at National level shall only be entertained for the purpose of sports category benefits if the respective State teams/contingents deputed by the J&K State Sports Associations are duly screened/recommended by the Screening Committee of the J&K State Sports Council.
