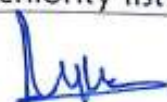
Whereas, the administrative department vide YSS-Adm/14/2022-02-YSS&S

If the Reserved Category Certificates (s) furnished by any official turns out be false/fake later on, the same shall be deemed to have been cancelled, ab-initio along with all such benefits which the official(s) would have availed on the basis of such false/fake certificates.

The seniority list so issued will be subject to outcome of writ petition(s) pending, if any, before any Competent Court of Law.
