ORDER

Whereas, the administrative department vide YSS-Adm/14/2022-02-YS&S Dated: - 16-01-2025 advised to update the seniority list of Physical Education Teachers in terms of SRO-375 of J&K Decentralization & Recruitment Act 2010 issued by General Administration Department; and

Whereas, the Directorate of Youth Services & Sports, J&K vide order no.
